

MEDIA AND MARKETING CONSENT

This Media and Marketing Consent (“Consent”) is separate from the East Football United Terms and Conditions and Privacy Policy.

East Football United (“Club”) may photograph, film, record, interview, or otherwise capture my name, image, likeness, voice, statements, playing activities, and participation in Club training, open play sessions, events, or related activities (“Media”).

This Consent is optional. It is not a condition of creating an account, making a booking, participating in training or open play, accessing the Club’s website or application, or availing of the Club’s ordinary services. Refusing or withdrawing this Consent will not result in a penalty or disadvantage.

Use of Media in the Club’s website, mobile application, and unpaid or organic posts on the Club’s social-media accounts.

Use of Media in advertisements or sponsored, boosted, or targeted digital content distributed through third-party platforms for which the Club pays to promote the content.

The Club will use the Media only for the purposes selected above and other processing reasonably necessary to carry out those selected purposes. The Club may crop, edit, caption, combine, or format the Media, provided that it will not use the Media in a misleading, defamatory, unlawful, or materially offensive manner.

The Club may engage service providers for photography, videography, interviewing, editing, hosting, advertising, publication, or related services. The Club will require appropriate contractual, organizational, and technical safeguards for such processing.

Continuing Consent and Withdrawal

This Consent may be treated as continuing for subsequent Club activities, bookings, and events while the scope, purpose, nature, and extent of the processing described above remain substantially unchanged.

If the Club introduces a materially different or substantially broader use of the Media, it will provide updated information and, where required, obtain new consent.
